test." Years ago, there were a number of such county yield contests, but today, "The Contest" is the only one of its kind in Bremer County – and perhaps the entire state of Iowa.

Sponsored by the two local, rural Bremer County banks in Readlyn and Tripoli, The Contest is a friendly competition between area farmers. The Contest Banquet provides Bremer County area farmers an evening of camaraderie and celebration of the previous year's harvest: Harvest 2021. The Banquet is held annually before spring at Center Inn with Sunrise Catering providing great appetizers, a superb prime rib buffet and dessert.

Following dinner, the bank heard from Jeff Brunscheon, general manager at Farmers Co-op in Readlyn. Brunscheon visited with the 60 banquet attendees and answered questions concerning the grain markets. Brunscheon emphasized diligence when making grain marketing decisions this year. This was Brunscheon's fifteenth straight year speaking at the banquet. We would like to recognize Jeff for all of his years of speaking his words of wisdom at the banquet. He plans to retire this June 2022 from the Co-Op and we wish him the best in retirement!

Doug Sheppard, Vice President of Readlyn Savings Bank, presented the first award of the night: The 12th Annual Vernon L. Tonne Spirit of the Contest. The Award annually honors the long-time enthusiastic and good-natured participation of a Master Grower who exemplifies The Spirit of the Contest. 

Jerry J. Seelhammer

Jerry J. Seelhammer, 80, of Shell Rock, Iowa and formerly of Denver and Clear Lake, passed away on April 11, 2022, at the Shell Rock Healthcare Center.

Jerry was born on December 9, 1941, in Waterloo, Iowa, the son of Mable (Warnke) and Henry Seelhammer. He attended Bremer Country Fremont #8, Country School #5 and then Tripoli High School, and graduated in 1959. On July 24, 1966, Jerry was united in marriage to Linda Clark at St. Peter's Lutheran Church in Denver. Jerry worked for Seelhammer Construction, Denver Machine and retired from John Deere after 37 years of service. At this time, he and Linda traveled for the next 12 years in their RV. Their summers were spent in Wisconsin, and they wintered in the warm southern states where Jerry worked maintenance in the various RV parks.

Jerry was a member of St. Peter Lutheran Church and served on the Church Council. He was the Charter President of the Denver Jaycees and was a member of the Denver Fire Department for 24 years, eight of which he served as Captain. Readlyn, Long Ago

Coming to America

Two Matthias families migrated to America from Algesdorf, Landkreise (County) Schaumburg, Germany, a short distance southwest of Hannover. These families were acquainted in Germany and attended the same Lutheran Church. The husbands in both families were named Johann William Matthias. J. W. Matthias, husband of CHRISTINE Louise Rohrsen, was born in 1826 and J.W. Matthias, husband of ENGEL Maria Matthias, was born in 1830.

CHRISTINE and J.W. Matthias arrived in Illinois in 1849 and moved to the Klinger area in 1856. ENGEL and J. W. Matthias arrived in Illinois in 1850 and moved to the Klinger area in 1857.

The families lived on adjacent farms and worked their farms together.

Children of CHRISTINE and J. W. Matthias were William (Willhelmina Pooock), Maria (F. L. Diekmann), Henry, (Carolina Knief), Fred (Caroline Byvank), Christine (William Diekmann), Fred (Sophia Bruns), Herman Matthias (Bertha Matthias), August (Otilie Finkensher), Louis (Alvina Schwake). My great-grandmother, Maria Matthias, died in childbirth, the baby 28 days later. Louis and Alvina Matthias, parents of Lorenz, Alvin, Arnold and Esther Happel, cared for the three Diekmann children until my great-grandfather remarried.

A Matthias marries a Matthias

Herman Matthias and Bertha Matthias were married May 10, 1894 at St. John, Maxfield, They were second cousins. They farmed near Klinger and retired to Readlyn and lived in the present Kaiser-Corson Funeral Home.

Their children: Bernhard (Frieda Rohrsen), Otilie (August Widdel), Herman (Charlotte Diercks), Edwin (Esther Schutte), Erna (died 1903), Paul (Erna Diercks), Lydia (Herman Moeller), Ruth, Elda (Lyle Carpenter) and Beata (Robert Murray).

In discussions as to which side of the Matthias tree someone belonged, Chris-

tine's or Engel's, Christine's descendants were called Little Matthias and Engel's descendants were Big Matthias. The distinction between Big and Little Matthias was that the Big Matthias men were taller than the Little Matthias men.

In Germany, Matthias is often used as a first name. My friend, Horst Fechtner, has a son named Mathias and a son-in-law Mathias.

Mrs. J.W. Matthias notes 92nd birthday

Mrs. J. W. Matthias, who will celebrate her ninety-second birthday June 12, is the subject of the article below printed in the *Bremer County Independent*. Mrs. Matthias is the oldest resident in Readlyn.

READLYN—Mrs. J. W. Matthias, Readlyn's oldest resident, was born in Germany on June 13, 1833. Like many others, her parents decided to come to America with the children to make their future home, so they started out in 1847 and came as far west as Chicago where they settled. They were there for seven years.

In 1854, an epidemic took her father and mother and one brother in one week. This tragedy left her with a sister and a brother to do all the work, which in those days was not a very easy task.

In 1864, she was married to J. W. Matthias. They resided there until November of 1865. They then started out for Iowa and settled in Maxfield Township, Bremer County.

Came in Covered Wagon

The railroad extended as far as Dubuque and from there they came by covered wagon drawn by two yoke of oxen. It was all open prairie from Independence to where Denver now stands and, since there were no roads or trails, they drove straight across country. They moved in with a cousin, Wm. Matthias, who had come out a year before.

Mr. and Mrs. Matthias acquired 80 acres of land nearby and started farming.

The grain they received from their cousin.

In those days, the grain was sometimes hauled to Independence where it was ground and some was traded in for supplies to be taken back. They also did some of their trading in Waterloo.

Money Was Scarce

Mrs. Matthias recalls the time when a toll of 25 cents was taken before crossing the bridge with a wagon and there were many times when they did not have 25 cents. Mr. Matthias would take small articles that he could carry across the bridge and sell, then would come back, pay the toll and drive across.

A barrel of salt cost \$7, eggs were 5 and 6 cents a dozen and a pound of butter about the same. Mrs. Matthias says, "We hardly ever had any money in the house, but took everything out in trade."

There was no machinery at first. Grain was cut with a cradle and hay with a scythe. The first grain cutter was purchased by J. W. and Wm. Matthias. The grain was cut during the day and tied toward evening and early morning when the grain was wet with dew. This was because straw that was used to tie the bundles would not break so easily. Oats was threshed by horsepower, four teams of horses driven in a circle. One hundred or 150 bushels threshed in a day was considered a very good day's work.

Mrs. Matthias said, "We never lived in a log cabin, having moved into the house with our cousin. The following spring we built a large house on the farm now occu-

Mrs. Matthias, with 366 Descendants, Dies Friday Special to the Independent

October 6, 1936 READLYN – Funeral service for Mrs. J. W. Matthias, believed to be the No. 1 great-great-grandmother in the United States, were held Tuesday afternoon from the home of her daughter, Mrs. Herman Matthias, and from the German Lutheran Church.

With 366 living descendants at the time of her death, Mrs. Matthias was thought to hold the United States record.

Surviving are her 10 children, 78 grandchildren, 237 great-grandchildren and 41 great-great-grandchildren.

Recently, considerable publicity was given to Mrs. Margaret Graeber of Sheldahl, Iowa, 93, with 12 children and 46 grandchildren, as the No. 1 U. S. Grandmother. Mrs. Matthias had 32 more grandchildren than Mrs. Graeber.

Mrs. Matthias was 98 years and four months old at the time of her death. She had been feeling well until the Sunday preceding her death when she became ill with bronchitis.

Was past 98 Years of Age at Time of Death

Engel (Biesterfeldt) Matthias was born and baptized in Hessen-Nassau, Germany on June 12, 1838, and died at the home of her daughter, Mrs. Herman Matthias, Friday evening, October 16, 1936, at the age of 98 years, four months and four days.

In 1847, she came to America with her parents, settling in Chicago, Illinois. She was bereft of her parents during a cholera epidemic in 1854.

On September 20, 1856 she was united in marriage with John W. Matthias, the Rev. Wunder officiating. The same year they came to Iowa and settled in Maxfield Township, Bremer County.

Mr. and Mrs. Matthias were the parents of 13 children. One son, Carl, died in infancy and two daughters—Christina (Mrs. William Hesse) and Louise (Mrs. Henry Schradt)—also preceded her in death. Surviving are her ten children—William C. Matthias of Orange, California; Sophia (Mrs. Fred Stahlhut) of Sumner; Emma (Mrs. H. J. Bruns) and Henry Matthias, of Denver; Iowa; Clara (Mrs. Wm. Seegers) of Waverly; Minnie (Mrs. C. H. Stumme), Engel (Mrs. C. Warneke); Mary (Mrs. John Richman); Bertha (Mrs. Herman Matthias); and Anna (Mrs. H. A. Griese) of Readlyn.; 78 grandchildren, 237 great-grandchildren and 41 great-great-grandchildren.

At present there are 364 direct descendants of this couple.

Mrs. Matthias was baptized, confirmed and remained a communicant member of the Lutheran Church all her life. Funeral services were held Tuesday afternoon, October 20, at the Herman Matthias home at one o'clock and in St. Paul's Church at two o'clock conducted by Rev. Theo. Frese. Interment was made in the St. Paul's cemetery.

On March 16, we had the opportunity to talk with local 4th graders about the importance of helmet safety and wanted to share some important information with all of you.

According to Norton Children's Neuroscience Institute:

-Head injury is the most common cause of serious disability and death in bicycle crashes

-A helmet can reduce the risk of brain injury

up to 88%

-Wearing a helmet is the single most effective safety device to reduce head injury and death from bicycle crashes

Signs and symptoms of concussion/brain injuries according to the CDC:

- Headache - Dizziness - Blurred vision
- Not thinking clearly - Sensitivity to noise and light

2024 Bremer County Reappraisal Project set to begin

Bremer County Assessor, Aaron Betts, is announcing the preliminary work for the 2024 reappraisal, which includes door-to-door inspections of all commercial, industrial, and residential property in Bremer County, was to begin approximately April 25. Representatives of Vanguard Appraisals, Inc. in conjunction with the Bremer County Assessor's Office will be conducting this project.

Each Vanguard employee has had a full background check and will have a photo ID signed by the Bremer County Assessor. All law enforcement agencies will be notified of Vanguard employees' names involved in the project, auto license numbers, and will be informed of the areas where data collectors are working.

The reappraisal purpose is to equalize

property assessments. Each taxpayer is then responsible for paying only their fair share of the property tax burden. Periodic inspections and reappraisals are necessary to update information and adjust for market conditions affecting property values. Some properties physically deteriorate faster than others and many have had improvements made. Also, property values in different areas of the county will differ in value due to economic factors.

Letters will be sent to property owners with further details closer to when data collectors will be in their town or area.

Preliminary data collection will begin with commercial properties and then move on to residential and industrial classes of properties. Work will start in Waverly and then

move throughout the county. The project is scheduled for completion the end of 2023.

Notice of final value estimates will be mailed to each property owner after January 1, 2024. Property owners will have an opportunity to meet informally to discuss their revaluation in the spring of 2024.

The reappraisal assessed values will be effective for January 1, 2024 for taxes payable in fiscal 2025-2026.

Dean R. French



When we left off last month, Jeff Schutte and I had just fired at our first group of hogs and Jeff connected with one. This month, we will finish out our Texas adventure.

Kaleb and I took care of Jeff’s hog and Kaleb, Jeff, Scott and I got back on the golf cart and headed to another section of the ranch in search of another group of hogs. Once again, we headed off into the darkness and Kaleb drove as if it were daylight. We were scanning with the thermal scopes and mostly were spotting armadillos and raccoons scurrying around in front of us. Suddenly, Kaleb stopped and said, “There’s hogs 20 yards to our right.” At that moment, I heard one snort. Kaleb handed me his rifle and I shouldered it and, through the scope, I counted a dozen or so hogs feeding on an old pile of pecans that had washed into a pile during last fall’s flooding throughout the river bottom. I picked out a good sized one, squeezed the trigger and connected! Jeff hit one at the same time and we were successful once again!

Immediately after the shot, the hogs turned and ran right towards us, passing by at a mere five yards from where we were standing. A little unsettling to say the least and most certainly had my heart racing. Once they were past us, high fives and congratulations were given as we approached our hogs. We took care of them and headed back to the ranch.

By this time it was quite late and we decided to turn in for the night. The next morning, we all slept in a little after the late night before. Jeff and I were the first ones up and hanging out around the fire at the shop. The weather was finally starting to warm up and the sun was out. We were forecast to climb near 70 this day and we couldn’t have been happier. Soon the rest of the guys were up and Scott’s youngest son, Blake, had arrived. Much like Kaleb, he’s a very hard-working, polite young man only much taller! I was greeted with “yes, sir” and “no, sir” and I gotta hand it to Scott and Wendy on the job they did raising both Kaleb and Blake, fine young men to be around for sure. Scott began making breakfast on the blackstone outside and, once again, some great eating as he made breakfast burritos. Over breakfast, we decided today would be another day of catfishing and a try at the hogs in the evening and night as the next day we would be heading for the coast.

We spent the next few hours bouncing from deep hole to deep hole in the river and had great success with everyone catching fish. I got to know Blake better as we sat along the river. He told me of his baseball career throughout high school and what he does now and where he lives. Jeff then came up with the idea of everyone throwing in a dollar and the next person to catch a fish wins the pot. I was instantly in as a little competition is always fun for me! I even surprised myself as, the very next cast, I hooked up with a nice catfish and the \$5 was mine! Jeff said, “That’s not fair, I should have never bet against a professional - what was I thinking?” I just laughed.

After the catfishing, we headed back to the shop and were greeted by Kaleb’s good friend Jared Thompson. Now if you were to look up “cowboy” in the dictionary, I’m pretty sure Jared’s picture is there. At least in this northern boy’s mind, that’s how I see it. From his look, with the hat and boots to his southern drawl and his friendly demeanor, you have to try real hard to not get along with Jared. We started talking hunting stories and what the game plan was for the evening’s hunts. Suddenly, we re-

alized if we were going to get a hunt in before dark, we better get moving, as we had lost track of time.

I would be back at the dump feeder with Jeff watching from the blind. However, on this hunt, I learned from the night before that I needed to play the wind better. This time I climbed up on top of a fallen over pecan tree that was still high enough to get my scent up out of the ground thermals. Once on top, I had a great place to sit comfortably and even a limb I could hang my bow from. At 4:45, the feeder went off spreading corn and I readied myself for the show. Soon after, deer started to make their way in and this time, by sitting in the tree, they couldn’t smell me and were less cautious. I had a great time watching the deer and, on this evening, no hogs were spotted. Jeff and I made our way back to the shop. Everyone was there including Jared and we all swapped stories for a while. Ben then relayed to me that we were nearly out of beverages and one of us needed to go to the store. Jared quickly offered to drive and away he and I went. We made our way to the Dollar General and back all the while never running out of things to talk about as we had so much in common with our passions for the outdoors.

While on our way back, he asked if I had ever been raccoon hunting before. I said it had probably been 20 years. He said, “Well, tonight you’re going raccoon hunting.” When we got back, Jared told Kaleb, “Let’s take these guys on a raccoon hunt” and just like that, Kaleb’s coon hound was loaded up and away we went! Kaleb’s coon hound was very impressive; shortly after we turned her loose in the front pasture, she was on raccoons. Kaleb tracked her every move with a GPS monitor on her collar. Soon she had a raccoon treed and we arrived at her destination. When we got there, she actually had three raccoons up the tree and Kaleb and Jared harvested the raccoons! High fives and many pets and praise to the pup and we had three raccoons to be skinned in short order. Jared looked at me and said, “I told you I’d take you on a great coon hunt!” I was very impressed with how quickly things happened!

It was at this moment I started to imagine this Texas lifestyle is so cool. The variety of game and options of hunting and fishing are a dream for an outdoorsman like me. It was now very late and we had to be up at 3:30 am to leave for the coast. When Jeff and I reached the cabin, it was 12:30 in the morning. I remember telling Jeff, “Have a nice nap, see you soon!” We both laughed, but reality set in when the alarm went off in what seemed like minutes after my head hit the pillow. Sleep was not much of an option with the fun we were having and honestly I’m OK with that. Jeff and I got up dressed and over to Kaleb’s by 3:45 as the plan was to leave by 4 am. The house was very dark as we pulled up and I was worried we would need to wake them up. Soon, I saw a light come on and everyone was up. We all managed to get on the road by a little after 4 am with Ben driving as he is accustomed to driving long hours. The trip would be myself, Ben, Jeff, Scott, and Kaleb. Blake had to get back home so he wasn’t able to go with us.

Weeks prior, Ben had researched guides in Aransas Pass, Texas. He came across an operation called High Tide Adventures with Captain Troy Butler for a redfish trip in the shallow waters of the Gulf of Mexico. This was not a deep sea trip as you might envision. This was a trip in a 22 foot boat powered by a Mercury 250 proxs. This type of fishing would be very similar to my world of bass fishing, only in saltwater and chasing red drum, or, as many call them, redfish or “reds.” It had long been a dream



of mine to chase redfish and this would be my opportunity.

As we made our way two hours south to Aransas Pass, I struggled to stay awake riding shotgun with Ben driving and the rest sleeping in the back of the Tahoe. I tried my best to keep Ben company, but succumbed to sleep myself. Ben gave me a nudge on the shoulder as we neared our destination. While still very dark, I could see water all around us and knew we were getting close. Everyone woke up and the excitement level was high as the GPS told us we were close. We arrived in the parking lot of an on-the-water bar and grill and Captain Troy Butler was there waiting for us, cutting up bait, with his boat already launched and tied to the dock. Greetings were made and Troy started to explain what to expect.

The weather was not ideal for reds. The wind was blowing 30 mph out of the northwest and the temp would only get near 50 degrees on the day. My bass fishing experience already had me knowing these cold front conditions would make fishing tough, but Capt. Troy had confidence he would get us on some reds, so I rolled with it. We launched from the dock and my experience fishing cold early spring bass tournaments paid off in this situation as I had layers on and an outer shell of Huk brand coat and bib overalls designed for stopping the wind in these conditions. That first ride was very brisk and I could tell Kaleb was a bit underdressed with a jean jacket and jeans. When we arrived on the first area to fish, we were all cold from the boat ride. I learned we would be using cut bait mullet and live shiners for bait on a weighted bottom rig, similar to catfishing in the river back home or what we had been doing for catfish on the ranch. About ten minutes into the first area, Scott hooked up with the first keeper redfish on the day - a short battle and Capt. Troy netted the fish and we were on the board! I remember thinking that was quick, maybe this will be a great day despite the conditions.

Not too long after Scott’s fish, I had a bite on my rod and set the hook too quickly - swing and a miss. I learned quickly I needed to give the fish more time before the hookset. Not long after, I looked over at Kaleb and he was shivering. I was plenty warm and I offered him my coat. He politely said, “No I’m fine.” I said, “Are you sure?” That’s when Scott spoke up and said, “He’s being polite, Eric, if you’re willing to give him your coat, make him take it!” Kaleb obliged and I felt better that he might be a little more comfortable. I think it might have been that moment that I felt like I was no longer “sir” and Kaleb and I could joke and be buddies.

Also at this time, the fishing that had hope turned south real quick. We spent the next three hours moving from spot to spot with no bites. It was cold, miserable and, as a tournament angler, I’m going to be completely honest here, by spot three I overheard Capt. Troy on the phone with his other guide buddy saying he had no idea what to do for us to catch fish and was out of ideas. I was honestly a bit disgruntled. “How are you as a guide going to charge us all this money and by spot three you’re out of options?” Any guide with a claimed 30 years of experience in an area should certainly have more than three spots to take us. I had a quick conversation with Scott at the front of the boat and he agreed as he spends a lot of time fishing the Gulf with friends. Scott relayed to me he had areas in mind that we could probably catch some fish. After a short time, we suggested to Capt. Troy that we go in for lunch and regroup our plan. Over lunch, Scott decided to tell Troy we were going to his spots to salvage the day. Surprisingly, Troy was willing and away we went.

On Scott’s first area, we got a couple bites but came up empty. On spot two, we spent a long time drifting down a section of bank and casting in open pockets among the weed beds. At about 2 pm, I finally decided I probably wasn’t going to get my red and instead of intensely fishing I decided to relax, grab a beer and a deer stick, and enjoy being on the water in a boat in January. I hadn’t even finished my deer stick when I felt a tap on my rod. I let the fish take the bait for a good bit and set the hook. I hadn’t even told the guys I had a bite until I set the

hook. I yelled out “Fish on, boys” while still chewing on a deer stick. I didn’t know it at the time, but apparently Ben and Scott had known what it meant to me to catch a keeper redfish as they both started videoing the battle. True friends indeed, and I didn’t even realize they had videoed until I got the fish in. I took my time so I didn’t lose it and, after a good battle, Captain Troy netted it and I had my first ever redfish! I was so excited, Ben and Scott snapped pictures and my trip to the Gulf felt almost complete! When I say almost, I still desperately wanted to see Ben and Jeff get a fish and I put my pole down in hopes they would.

Four o’clock came very quickly after that and our day on the water was done. We made our way back to the dock and Troy cleaned the fish for us. We had a bit of a show as the gulls swarmed around looking for fish scraps. After the fish were cleaned, we paid Troy his guide fee and started our way back to the ranch. We all were very tired on the ride back from getting up so early to being out in the elements all day. The two-hour drive seemed like four hours as it was Sunday and Ben, Jeff, and I knew our flight home was tomorrow, while Scott and Kaleb had to be at work early Monday morning. At arrival back to Kaleb’s, we were greeted by Jared as he wanted to hear how the fishing trip went. We all hung out around the fire and Jeff went from the house to the fire keeping us updated on the NFL playoff games. As we hung out enjoying our last night at the ranch, Kaleb’s girlfriend, Mikaela, and his daughter, Harlow, arrived back home to the ranch from their visit over the weekend to Mikaela’s parents. Mikaela had just bought a new vehicle and it was entertaining to listen to Jared joke with her about this scratch or this dent. Of course, there wasn’t and he was giving her a hard time. We all went in the house and I thanked Mikaela for opening up her home to us over the time we were here. I then had fun talking to Harlow as she’s only a couple of years old and took me back to my daughter being that little.
