# Highs and lows mark 2020 for the Becker family

It was about a year ago on a Thursday, that Josh and Alissa Becker had a visit from Josh's brother, Nick Becker. Currently serving at the naval base in Groten, CT, Nick was on leave and came home to visit his family. When he saw his nephew Liam, he was concerned that he looked so pale. Nick had a toddler of his own, and thought Liam also seemed to have an excessive amount of bruising, and his energy was really low. Josh and Alissa had noticed this, but hadn't given it too much thought; Alissa is fair skinned, and these changes had come about so gradually.

That evening the family gathered together in Jesup with Josh's parents, Dave and Marcie Becker. Because Josh and Alissa were both going to work the next day, Marcie volunteered to take Liam to the doctor. He was seen by Dawn Kleve, ARNP, at MercyOne in Jesup. Kleve consulted with Liam's primary care provider, Stefani Pitkin, PA-C. Lanette Bloes took a blood sample which they immediately sent to Covenant Hospitals in Waterloo.

An hour after their appointment, Josh received a phone call from the clinic that they were concerned about Liam's blood work. Forty-five minutes later, another pitals informed Josh that his son was diagnosed with leukemia.

The Becker family's lives would be forever changed from that point on. They rushed Liam to Iowa City where he was given an IV. On Saturday a port was surgically implanted to receive the chemotherapy that would be a big part of his life going forward

That initial hospital stay lasted seven days. He would return to Stead Family Children's Hospital once a week for chemotherapy for the next 11 months.

Last month the family got some good news. Liam's condition had stabilized to the point he could go on a "maintenance" schedule of monthly treatments. Alissa is excited that Liam now has more energy, his color has come back, and his hair is growing

Josh and Alissa and their children live just east of Jesup. Josh had been working for the railroad, then took some classes at Hawkeye Community College, and has now joined his dad's business, Dave's Electric.

Alissa is employed by VGM in Waterloo, and says they have been very supportive. Alissa's co-workers at VGM

Rhoades has experience with Bosco gear, and was able to coordinate with Alissa's friends at VGM to make it happen.

> Alissa was furloughed from VGM due to COVID-19, and is now on maternity leave. While they were going through the initial shock of Liam's diagnosis, they got another surprise: Alissa was pregnant! Archer James Becker was born June 23; he joins sister Gracie Lu, who is one (turning two years old in November). Liam is two years old (turning three in October).

> Alissa says, "At the time of Liam's diagnosis we had two under two, now we have three under three!"

> Alissa grew up in Readlyn, and is very appreciative of the support they have received from their families and friends in Readlyn and Jesup, as well as siblings that don't live close but have made an effort to come more frequently and help out. Alissa is the daughter of Barry and Lisa Wittenburg of Readlyn. Josh also has family in Readlyn: his sister Ashley married Alissa's cousin, Isaac Happel. LuAnn Happel is Liam's grandmother, and Betty Becker of Jesup is Liam's great-grandmother.

> Alissa said, "It is never good timing for something like this, but we know we are in the best hands possible. We are making life the best it can be, and adjusting to our new normal." Josh and Alissa are so thankful for their incredible support system of family and friends in the

It will come as no surprise that this young family has a lot of extra expenses related to Liam's diagnosis. He has five oral medications on the kitchen counter. Some he takes daily, some are on other schedules. Alissa says the UI pharmacy and the Jesup Pharmacy have both been as accommodating as they can be, but there is still co-pay.

If Liam gets a fever, he is required to stay at the hospital for seven days. Since only one parent can be with him (because of COVID-19) they take turns, neither wanting to compromise their work obligations. That is a lot of trips to Iowa City. Friends have given them gas cards, and the UI Dance Marathon has also been a source of financial assistance.

When Joe Miller heard about Liam's condition, he felt compelled to do something, but what? Joe travels a lot for work, but lives in Fairbank. He has been good friends with Liam's grandfather, Barry Wittenburg, since they met at Wapsie Valley School in the eighth grade. Joe and another friend, Todd Kuethe, decided they would host a fundraiser. Before they could get it organized COVID-19 hit, and all plans changed.







# The life and times of Glenn Wittenburg

Glenn Wittenburg was born in 1926 to Ted and Bertha Wittenburg. He had four brothers, Delbert, Arlin, Leo, and Elmer. All were mischievous, fun-loving and on the wild side. However, Glenn stood out from the group.

He married Helen Hills on October 8, 1944. They had three sons, Denny, Rod and Barry. I have written an account of some of Glenn's antics, some from my own recollection and some from friends of Glenn. I left Readlyn in 1959. All of these escapades happened more than 60 years ago. Glenn owned his own trucking business at that time.

### Al Fortsch

Al was riding along with Glenn delivering a load of corn to somewhere in Missouri. The truck was underpowered. Glenn had to increase speed downhill so going up the next hill was easier. They were riding along picking up speed going downhill. There was a town at the bottom of the hill. Glenn barreled through the town. Unfortunately, a cop was sitting in a police car and soon, lights flashing, he chased us up the hill.

Glenn quickly stopped the truck, jumped out and approached the officer, who had never seen him before and said to the officer, "Hi there! How are you today? I haven't seen you in a long time. How's the family?" The policeman was taken aback from Glenn's greeting, thinking that he surely must know Glenn. He did not give Glenn a ticket. Al was shocked.

### Vince Maurer

Vince was riding in a car with Glenn on Highway 3 circa 1947. They were traveling east somewhere between the Big Corner and Readlyn. Glenn was around 23 and Vince was 19. There was oncoming traffic. The car they were following was going too slow to suit Glenn. Glenn, out of patience, turned right, off onto the shoulder, and passed the car on the right. This was more than 60 years ago when Highway 3 was more narrow and the shoulder was also narrow. After pulling back on the road, Glenn, with a straight face, looked over at Vince and said, "When I was younger I did a lot of crazy stuff but now that I'm older, I've got a lot more sense."

### Vern Schweer

Vern had just gotten a new bicycle. Somehow the bike got out onto Highway 3. Glenn was on the bicycle hanging onto the side of the car. Whoever was driving the car kept going faster and faster. There was Glenn, hanging onto the side of the car, traveling 80 miles an hour down the highway. Scary?

### Wilbert Hagenow

One evening, while in Waverly, Glenn spotted two cops sitting in a squad car. He recognized both. He sped past them, baiting them into a chase. The chase was on!

They went tearing around Waverly, cops' lights flashing, through alleys, side streets, etc. Finally Glenn lost them. However, the cops knew who they were chasing.

Helen's parents lived in Waverly and they knew Glenn's car was parked there. They went up to the door, knocked and were invited in. Wilbert said that Glenn had the cops laughing so hard they never even gave him a ticket.

### **Bob Thra**

Glenn and Elmer finished a job shelling corn on a farm near Fredricksburg. They were moving to another job near West Union. To save time in the move, they tied a rope from the com sheller to a small tractor, then hitched the elevator onto the tractor, then added some drags. A patrolman stopped them and accused Glenn of being too long. Glenn argued that the tractor broke down and he had to get it off the highway.

The patrolman didn't buy. He gave Glenn the end of the tape measure and told him to hold it at the front bumper. Glenn said he cheated by slowly moving past the cab all the way to the sheller. The patrolman announced they were 50 feet too long. The fine for being over length was one dollar an inch. Fifty feet equals 600 inches. A dollar an inch meant a fine of \$600.

A helluva lot of money in the '60s. I had recently bought a brand new Ford for \$1400.

Glenn was told to appear before the Justice of the Peace in West Union.

He asked me to ride along. The JP was not home. His wife said he was at the Fayette County Fair. We searched at the fair and found him. He invited us back to his office. He looked up Glenn's case in his records and then said firmly, "\$600 plus \$7.00 court costs." Glenn protested by explaining to him that the tractor broke down and he had to get it off the highway.He also didn't buy Glenn's story. After more discussion, the JP summed it all up by saying, with a little sympathy in his voice, "\$600 is a lot of money and you had to go out of your way to look for me at the fair." (At this stage it appeared he might hopefully lower the fine). However, his abrupt verdict was "\$600 fine and I'll drop my \$7.00 cost." What a let down.

### **Ted Wittenburg (Glenn's father)**

I was visiting with Ted when he said while laughing, "That devil (meaning Glenn) goes around and visits all the weigh stations in the area before Christmas and gives each of the workers a fifth of whiskey."

### Wayne Kuethe

Glenn was hauling a load of rock traveling south on Highway 63, near the Tripoli turn-off. A patrolman stopped him and ordered Glenn to drive to the weigh station located several miles south at the corner of Highway 3 and 63, to be weighed. Glenn knew he was overweight. To solve his problem he flipped the switch, spreading rock on Highway 63 to lighten the load. He weighed legal. Problem solved.

Harlan Heineman, who was married to Wayne's sister, Judy, was riding with Glenn hauling hay. Harlan noticed a hatchet in the cab and asked Glenn what the hatchet was for. Glenn's explanation was: If ever he is overweight with a load of bales and is stopped by a patrolman he can chop the rope so that bales would fall off the trailer.

### Denver's Exciting Fritz "Speed" Wittenburg

Glenn had an uncle, Fritz Wittenburg, who lived in Denver. I remember him as being a businessman in Denver. In his younger days, Fritz was known far and wide for operating a successful business, distributing alcohol during the prohibition era. In simpler terms, he was a well-known bootlegger.

Some alcohol sold was distilled locally, but most came from a source in East Dubuque in Illinois. Fritz would often make runs along the same road (present Highway 3) to pick up his supply of booze. Law enforcement officials along the way became aware of Fritz and his ac-

tivity. The story is that they often tried but were unable to stop him. He and his Model T Ford outran them. I was told that he was given the nickname "Speed" by those lawmen who were not able to catch him.

Speed Wittenburg and Elda had two sons, Luverne and Don. Don and Esther Wittenburg live in Denver. Don is 92 and Esther, 91, and they have been married 72 years

### Arnold

This is my recollection of the great donkey saga in Readlyn. Glenn was at an auction. Arnold Hexom was the auctioneer. My guess is that when Arnold could not get an opening bid on a donkey, he taunted Glenn into bidding. Glenn bid and got him for a dollar. He named the donkey Arnold in honor of Arnold Hexom. He brought him back to Readlyn and housed him in a shed located near their present property.

Arnold was involved in one of the greatest crimes in the history of Readlyn. Some dastardly culprits kidnapped Arnold. He went missing for a time. I heard Arnold was located east of Klinger, near the seven bridges. Glenn brought Arnold back home and put him to good use.

As shown in the picture below, you can see that Arnold is proudly riding in the back of Glenn's car. Glenn would first load Arnold onto the car, then hitch a cart behind the car. Glenn and Arnold would travel to towns in the area having celebrations and be in their parades. He and Arnold were good advertising for Glenn's trucking business.

The story about Arnold is an example of Glenn Wittenburg's devilish, fun-loving character. He had charisma. He was fun to be around. You would never know what would happen next. I enjoyed him as a friend. If everybody were alike, wouldn't this be a boring world?



The Wapsie Valley Community School District is off to a great start for the 2020-21 school year. Even though it is a "unique" school year with a pandemic occurring around us, the ultimate goal is still the same. The WVCSD Mission Statement - Guaranteed Learning for All Students - still applies as much as ever. There have been countless hours of collaborative efforts the past four months engaging the 15 member Building Leadership Team in developing the Return to Learn Plans required by the Iowa Department of Education. These plans can be found at the Wapsie Valley CSD website at wapsievalleyschools.com. There are four different plans developed to guide the district in different scenarios. The four plans are an On-Site Plan, a Hybrid Plan, a Required On-line Plan, and a Remote Learning Plan for our four Amish rural buildings. At the present time, the majority of students are utilizing the On-Site Plan and 25-30 students have chosen the long-term Hybrid Plan, where all of their instruction is offered in an on-line virtual format.

I would like to welcome several new staff members to the Wapsie Valley family. 

### "Finally!"

Fall is here and many of us, myself included, are preparing for the hunting seasons that are here or nearly here. I am very excited about this fall's hunting, but I'm not done with the 2020 tournament season just yet. I still have two tournaments left on the schedule in what my partner and I have named "The Eric and Adam, season of suck."

Now, it hasn't been all bad, as we've spent a lot of time together in the boat and have had a lot of laughs, but the finishes have been sub-par by our standards. Well, I'm happy to announce we finally had a better tournament on September 12! This month I'll break down the story of the day and how we caught our bass on a fall pattern.

For a straight week, before this September tournament, it rained nearly all day, everyday. I surely thought this would change what had been a very stable Mississippi River through August and early September.

As I drove over the Marquette bridge Friday evening on my way to our cabin in Prairie du Chien, I was pleasantly sur-

n Prairie du Chien, I was pleasantly surprised to see the river had not changed much at all through the week and looked, for the most part, to have stayed clean. I arrived at our cabin around 7 PM and was greeted by my tournament partner, Adam Farmer. Adam and his wife bought the cabin right next door to ours over the summer and it's great for Adam and me as we are right by each other at the river and can strategize and game plan right there before a tournament.

This tournament was the Bass World Sports Association out of Lansing, Iowa. Neither myself or Adam could get off work to practice for this tournament so we were fishing it without really knowing what the fish were doing. It had been much colder all week with the rain and we were looking at having our first taste of a true fall pattern of the season.

Generally, when the water temperature drops off ten degrees from what it hovers around all summer, the bass and all species of fish will move shallow in search of schooling baitfish to bulk up in preparation for winter. As Adam backed me in that morning and I turned on my Lowrance fish finder, the temp read 61 degrees. I thought to myself "game on!" The fall bite is here!

As I cranked the motor it would not start, I tried everything I could with the limited tools I had in the boat as everyone watched me. It was frustrating with all the guys in the tournament yelling try this, try that, and nothing working. As the tournament director walked down the dock, I trimmed the motor all the way





down in an effort to level the carbs and amazingly enough it started with 30 seconds to spare!! Cue the dramatic movie music as we idled out of the marina boat number two! I told Adam, I don't think my heart can take these dramatic moments anymore!

As we took off, like I said, we didn't have any practice and I really didn't know what stage the fish were in, but with the temperature drop, I decided to start on a main channel point with a long sandbar that was just outside of a massive backwater area that the bass had spent the summer, but would now be moving out to find baitfish.

As we arrived on the area, it looked ideal for the fish to be there in a fall pattern. There were baitfish popping the surface everywhere and we quickly found out the fish were there. I quickly boated a keeper bass on a topwater Poprand shortly after, Adam boated a keeper bass dragging a Texas rigged black and blue tube across the sandbar. But just as quickly as we boated those fish, the bite slowed. We caught a few more fish on this spot, but no more keepers.

There's a rock point within sight of this spot where I'd done well in the past. I wanted to go to it and we both knew a boat had already started on and fished the spot, but I had so much confidence in the area, we decided to go to it. This point is set-up perfect for fall bass, it features a wing dam with fast water rushing into a point and breaking the water to create a slack pocket.

I rarely fish the slack pocket here as the active fish are usually up on the wingdam corralling bait. I was fishing the fast water with a Rapala DT6 crankbait and Adam was fishing the slack water with his tube bait. He quickly hooked up on

a very nice 2.75 pound bass and then backed it up with another solid fish. He was on fire, and I was almost cheering him on from the front of the boat. We soon rounded out our limit of five and started upgrading our limit. I hooked up with our best bass of the day on my crankbait in the fast water, a 2.83 pounder. We soon had what we felt was an OK bag and were still looking for a real solid fish for our kicker to really improve our five fish limit.


There is a wingdam just across the river from this spot where I had done well in previous years and had caught some real solid fish on. We slipped over and tried it in hopes of finding a big one. All we could muster up was two pounders, nothing to help our limit.

As the day rolled on, we fished these three spots, all in sight of each other in rotation. We would jump around in a triangle and each time we let a spot rest it would reload with fish. We ended the day catching well over 75 bass by this strategy. As it neared two o'clock, our check in time, we raced for the ramp. As we idled into weigh-in, we fist-bumped and said to each other, no matter what happens at the scale we had a great day. We loaded onto the trailer and got in line for the weigh-in. We crossed the scales with five fish for 12.53 pounds, good enough for third place and a decent paycheck for our efforts. We finally had a good finish this year!!! We were happy on the ride back to our cabins for sure!

If you get a chance to take in some fishing as we head further into fall, keep in mind to follow the baitfish and you'll find fish, no matter the species you're after

Have a great fall season everyone and until next month, GET OUTDOORS!!!











